1. Organisation, preparation and conduct of the competition

1.1. The preparations for the tournament and its conduct are the Tournament Organiser's responsibility. The RPF, represented by the tournament director Vladimir Vladimirovich Osipov, is responsible for all operational issues arising before the start and during the tournament.

1.2. The official ball of the tournament is the Nox (or another ball as decided by the Tournament Organiser).

2. Tournament format and participants

2.1. Sport discipline – doubles (individual competitions).

2.2. Men and women who have reached the age of 15 before the tournament start day, having the corresponding FIP and/or RPF ranking at the moment of the application deadline, and having medical clearance that is valid as of the dates of the tournament (cl. 3.6.) and accident insurance (sports insurance) **are allowed to participate in the individual competitions.**

Players who have a valid disqualification (or provisional suspension) for violating anti-doping rules, as well as players who have a valid disqualification, ban and/or suspension from participating in competitions for violating the Disciplinary Regulations of the RPF, the Code of Ethics of the RPF, the Code of Ethics of the International Padel Federation (hereinafter referred to as FIP), the Code on the prevention of the manipulation of FIP competitions are not allowed to participate in the competitions.

2.2.1. If a player has RPF ranking points, these points will be converted into FIP ranking points at the ratio of 1 to 40 (1 FIP point equals 40 RPF points). Thus, a player with both RPF and FIP points is entitled to use the highest value of ranking points for tournament entry. For the purpose of creating a Players' list, **the highest number of points is selected** using the FPR or FIP system.

2.3. 16 pairs of men and 16 pairs of women from among those who applied will be selected to **participate in the main draw** as follows:

- 12 pairs of men and 12 pairs of women ranking highest in the ranking as of the closing date for applications;
- 2 pairs of men and 2 pairs of women who received a wild card from the Organiser:
 - the pair of men and the pair of women who took the first place in the RPF FONBET Cup of Russia tournament (May 18-24, 2026), according to the wild card provided by the Organiser. If the winners of the FONBET Cup of Russia decide to enter separately from each other (in pairs with other players), they will be admitted in accordance with the general procedure. In this case, the Organiser will give the vacated wild card to any pair at its decision;
 - the pair of men and the pair of women who received a wild card based on the decision of the Organiser. The Organiser will decide whether to grant a wild card no later than October 13, 2026. If there are no pairs who have received a wild card from the RPF, pairs from among those who have applied on the basis of the ranking will be allowed to participate;
- 2 pairs of men and 2 pairs of women who won the semifinal matches of the qualification.

2.4. The competitions of the main draw will be held according to the **Olympic system with the drawing of the 3rd place**. The Olympic system is an elimination system for sport competitions, in which the first defeat of a participant (pair) ends their participation in the sport competition, and the winner is the participant (pair) who wins all their matches. The match for third place is played between the participants who lost in the semifinals of the tournament.

2.5. All matches in the main draw consist of three standard sets with a tiebreak to 7 points at 6:6. The pair needs to win two sets to win the match. When the score is 1:1 in sets, the decisive full set will be played.

The score format is a “star point” system. When a pair wins its first point, “15” will be called, on the second point won “30”. At the third point “40” and the fourth “game”. Except, if each pair have won three points, at which time “deuce 1” will be called. The following point won “advantage 1” is called in favor of the pairs who won the point: then, if the same pair wins the next point they win the game, if the point is lost the score will return to “deuce 2”. The following point won “advantage 2” is called in favor of the pairs who won the point: then, if the same pair wins the next point they win the game, if the point is lost the score will return to “deuce 3” and a deciding point called the “Star Point” will be played. The receiving pair will choose whether to receive the service on the right or the left side of the court. The players of the receiving pair cannot change positions to receive the deciding point. The pair that wins the “Star Point” wins the game.

2.6. 16 pairs of men and 16 pairs of women will **participate in the qualification**, as follows:

- 8 pairs of men and 8 pairs of women from among those who applied and did not pass to the main tournament occupying the highest positions in the ranking as of the date of application deadline;
- the Organiser may give a wild card to 8 pairs of men and 8 pairs of women, including Russian players. If there are no pairs who have received a wild card from the RPF, pairs from among those who have applied on the basis of the ranking will be allowed to participate.

2.7. Qualification matches will be held in accordance with the Olympic system without a draw for the final match.

2.8. Matches 1\8, 1\4 of Qualification consist of two standard sets with a tiebreak to 7 points at a score of 6:6. To win the match, the pair needs to win two sets. If the score is 1:1 in sets, the decisive tiebreak to 10 points is played. If the score is 9:9 in the decisive tiebreak, the game is played until there is a two-point difference.

Matches of the final round (semifinals) of the Qualification consist of three standard sets with a tie-break to 7 points at score of 6:6. The pair needs to win two sets to win the match. When the score is 1:1 in sets, the decisive full set will be played.

3. Registration for the tournament and admission of participants

3.1. Only pairs can apply for the tournament.

3.2. Applicants must submit their application **no later than 12:00 noon on September 25, 2026**.

3.3. Those wishing to participate in the tournament should submit a pair entry form online at: <https://moscow2026.padelrus.ru>.

3.3.1. By submitting an application for the tournament, each participant confirms his consent to the processing of his/her personal data, as well as to recording, photographing or video recording during the tournament, using his image and (or) voice during the preparation/ holding of the tournament, broadcasting or publishing them by the Organiser and/or the Organiser's partners

anywhere in the world, in any media, including, but not limited to, television, radio, the Internet, newspapers, magazines and other means of advertising or marketing in connection with this tournament and/or future tournaments. Participants are not entitled to any compensation for such usage. Participants' consent is given for an indefinite period.

3.4. The list of participants is formed based on the ranking. Pairs with higher rankings have a priority right to be included in the main draw list. Pairs with lower rankings are moved to the qualification draw list, even if they were previously on the main draw list. If all the qualification draw positions are occupied, the participants are moved to the waiting list, even if they were previously on the qualification draw list.

3.5. No later than 20:00 on September 30, 2026 the Tournament Organiser will publish the list of pairs admitted to the tournament with the total ranking of the pair on the tournament website <https://moscow2026.padelrus.ru>.

3.6. At the stage of admission to the tournament the compliance of players with the requirements set out in p.2.2. is checked, including the player's possession of the following documents **valid as of the dates of the tournament:**

- a medical clearance document (for Russian athletes, a certificate from a medical institution licensed to carry out medical activities and practicing (providing services) in the area of sports medicine and / or therapeutic physical education and sports medicine, in accordance with and in the form specified in Order No. 484n of the Ministry of Health of the Russian Federation, dated June 19, 2026, containing the name and date of birth of the athlete and confirming the absence of contraindications for the athlete to engage in sports, including participation in competitions, signed by the doctor and bearing the stamp of the medical institution); and for foreign citizens, a certificate confirming that they can participate in the padel competition, issued in the form used in their country of residence;
- parental consent for participation in the tournament for players under 18 and over 15 y.o. (Appendix 1);
- accident insurance (sports insurance), as conformed by an insurance policy indicating the type of sport – padel.

3.7. Copies of the documents specified in clause 3.6. should be attached to the application via the link in clause 3.3. or sent to the following e-mail address: moscow2026@padelrus.ru **not later than 12.00 on September 25, 2026** (which is the same as the deadline for receipt of applications for the tournament). In the absence of one or more of the documents specified in clause 3.6, the player is not allowed to participate in the competition.

3.8. Withdrawal from the tournament of pairs who were admitted to the main tournament based on their ranking after the publication of the list of pairs admitted to the tournament (**after 20:00 on September 30, 2026**) without a valid reason is not allowed.

3.9. The valid reasons include cases of injury or illness confirmed by relevant medical documents sent by e-mail to the official address of the Tournament Organiser, the validity of which is confirmed by the Chief Tournament Doctor.

3.10. In order to withdraw from the tournament, the player should send a withdrawal request to the e-mail address of the Tournament Organiser: moscow2026@padelrus.ru.

3.11. In the event of withdrawal of a pair from the main draw the Tournament Organiser may make

a decision to provide an additional place in the main draw for a pair from the qualification.

3.11.1. In case of withdrawal of a pair from the main draw before the draw itself a place in the main draw will be given to the pair from the qualification with the highest ranking.

3.11.2. If a pair withdraws from the main draw after the draw the winning pair of the match between the pairs that lost in the semi-finals of the qualification will enter the main draw. If there is no possibility to play an additional match, the pair that gets into the main draw will be determined by a lot (Lucky Loser pair).

If a seeded pair is withdrawn from the main draw, their place in the draw is taken by the highest-ranked unseeded pair, and the highest-ranked unseeded pair is replaced by the winner of the match between the pairs that lost in the semifinals of the qualifying tournament (or the Lucky Loser pair).

3.12. In case of withdrawal of a pair that was admitted to the qualification the Tournament Organiser has the right to give a place in the qualification to a pair from among those admitted to the tournament but who did not get into the main draw and qualification based on their ranking. The pair with the highest ranking has a priority right.

3.13. In case of a withdrawal after the draw both in the main draw and in the qualification the Organiser follows the principle of minimizing the impact on the pairs distribution across the tournament grid.

3.14. When applying for the tournament a pair should specify one or two coaches who are authorized to be present with the team during matches.

3.15. Only one coach for each pair may be present at each match. If more than one coach is indicated in the application form or if there is no coach from among the coaches specified by players, the pair is obliged to inform the Chief Umpire by naming the coach for the match not later than 1 hour before the start of the match. However, the said coach may not be a current tournament player and must be accredited as a coach.

3.15.1 To obtain a “Coach” accreditation are entitled:

- persons who have an RPF certificate for training courses;
- persons holding a training certificate / license of a foreign Padel academy;
- TOP-40 players in men RPF ranking or the TOP-20 players in women RPF ranking or the TOP-250 in men FIP ranking or the TOP-200 in women FIP ranking.

3.16. The coach has the right to give cues to the pair during authorized breaks in the match.

4. The deadline and format of the draw

4.1. The draw for the main tournament and qualification will be held by the Tournament Organiser and broadcast in the official community of the RPF, “Padel Russia”, on the website VKontakte (<https://vk.com/padelrus>) **not later than October 19, 2026, and time of the draw will be determined later.**

4.2. Before the draw for the main tournament, 8 seeded pairs will be determined based on their ranking. The 1st and 2nd seeded pairs will be placed, respectively, on the first and last position of the tournament grid. The 3rd and 4th pairs will be drawn so that there is a probability of their meeting with the 1st and 2nd pairs not earlier than the semi-finals. The pairs in positions 5 to 8 will be arranged by lot so that there is a probability of their meeting with the pairs in positions 1 to 4 not earlier than the 1/4 finals. The remaining pairs, including the two pairs that received a wild card and the two pairs that entered the main draw from the qualification, will be drawn to unoccupied grid positions.

4.3. Before the draw of the qualification 4 seeded pairs will be determined based on their ranking. The 1st and 2nd seeded pairs will be placed, respectively, on the first and last positions of the tournament grid. The 3rd and 4th pairs will be drawn so that there is a probability of their meeting with the 1st and 2nd pairs not earlier than the semi-finals. The remaining pairs, including the pair that received a wild card in the qualification, will be allocated by draw to unoccupied grid positions.

4.4. Based on the results of the draw the Tournament Organiser will publish the tournament grids and the schedule of matches of the qualification and main draw on the tournament website (<https://moscow2026.padelrus.ru>) not later than **23:00 on October 19, 2026**.

5. Refereeing

5.1. The Chief Umpire is responsible for organising the referring of the tournament.

5.2. The schedule of matches and allocation of matches on the courts will be drawn up by the Chief Umpire immediately after receiving the results of the matches of the tournament previous stage. Rescheduling matches to another court and shifting matches at the request of players in the absence of objective reasons and without the agreement of the Chief Umpire and the Tournament Director is not allowed.

5.3. All matches of the main draw will be held with the participation of umpires-observers or chair umpires (by the decision of the Organiser depending on the technical possibility).

5.4. In a match each pair has the opportunity to refer to the electronic review (video review) in the event of disagreement with the umpire's decision. Video review is provided to each pair once in each set. The video review may be used immediately after a disputed point without proceeding to the next point. To use video review the player of the pair must contact the match umpire explaining the moment in the match that the player wishes to clarify.

The result of the video review is the final decision of the match umpire and cannot be appealed. In case that a video review resulted in a change in the umpire's decision, the right to a video review in a set shall be retained. If the video review does not lead to a change in the umpire's decision, the player loses the right to use a video review in the current set. If the video umpire is unable to assess the disputed moment on the video review, he will inform the match umpire who requested the video review. In this case, the match umpire has the right to retain his original decision or to replay the point, and the players' (who requested the video review) right to a video review in that set is preserved. Unused video review does not carry over to the next set.

6. Additional provisions

6.1. Due to the organisation of the broadcasting of the tournament matches online players in the same pair **must** perform in jerseys of identical colors throughout the match. If the players do not have uniforms of identical colors, the Chief Tournament Umpire has the right to request the players to play the match in the t-shirts provided by the Tournament Organiser. **If the players refuse to play in t-shirts of identical colors, the pair will not be allowed to play in the match.**

Opponents in a match must wear t-shirts with contrasting colors (for example, one pair in white and their opponents in black). The pair with the highest ranking has priority in choosing the color of the t-shirt. The other pair in the match must choose a color that contrasts with the color of their opponents.

6.2. Every player, coach, representative, official and other subjects of padel participating in the Tournament, by the fact of their participation in the Tournament, recognize and undertake to comply with the officially approved by FIP rules of padel, the provisions of the Disciplinary Regulations of the RPF, the Code of Ethics of the RPF, the World Anti-Doping Code, FIP Anti-Doping Rules, All-Russian Anti-Doping Rules, as well as other regulatory acts of the RPF and FIP regulating legal relations in padel.

6.3. Every player, coach, representative, official, and other participants of the Tournament, by participating in the Tournament, acknowledges the exclusive jurisdiction of the RPF Control and Disciplinary Committee and the National Center for Sports Arbitration in dealing with any disciplinary issues or disputes that fall within their jurisdiction.

The participants listed in this paragraph are obligated to strictly comply with the decisions of the RPF and FIP jurisdictional bodies, which are made in accordance with the relevant regulations.

6.4. Accredited persons, participating in the tournament are not allowed to pass their accreditation badge to other persons. In case of violation of this clause the person who committed the violation is excluded from participation in the tournament in any status, and the accreditation badge is returned to the Organiser. Transfer of the accreditation badge is a serious violation, and the issue may be considered at the sessions of the jurisdictional bodies of the RFP and FIP.

6.5. The Tournament Organiser assumes the right to consider force majeure situations on an individual basis and act at its discretion in relation to such circumstances.

7. Services for participants and referees

7.1. Visa support

Information support will be provided to foreign participants and referees who require a visa to enter the Russian Federation. The visa fee will be paid by the Organiser.

7.2. Travel tickets and transfers

7.2.1. The Tournament Organiser will **provide round-trip travel tickets only for the tournament pairs in seeding positions 1 to 8 (16 men and 16 women)** and for foreign umpires. Other

participants are responsible for purchasing their own travel tickets and should inform the Organiser about the date and time of arrival/departure by sending copies of the travel tickets to the tournament e-mail address: moscow2026@padelrus.ru after their purchase to allow the planning of transfers.

7.2.2. The Tournament Organiser will provide transfers for players and foreign umpires on the following routes: airport- official hotel-airport, official hotel-competition venue-official hotel.

7.3. Accommodation

7.3.1. The Tournament Organiser will provide twin-room accommodation for the main draw players from October 21 to 26 in a hotel of category not lower than 4*. Accommodation on additional days due to the impossibility of purchasing travel tickets for the specified dates should be agreed with the Organiser separately.

7.3.2. If a player needs single accommodation, he/she should make a corresponding request to the Organiser to the tournament email moscow2026@padelrus.ru to check the availability of rooms and make a reservation. The player will be responsible for paying the extra charge for single accommodation at the accommodation hotel.

7.3.3. The Organiser will provide accommodation to foreign umpires in a hotel of at least 4* category based on the schedule of their preparations for the tournament and work at the tournament, which will be determined at a later stage. The Chief Umpire shall be provided with single accommodation, the Organiser shall provide the other umpires with twin room accommodation, taking into account their gender.

7.4. Food & Beverages

7.4.1. Players and umpires will be provided with hot meals in buffet format 3 times a day in the hotel.

A schedule will be provided at a later stage.

7.4.2. At the venues self-service snack bars will be organised. During trainings and competitions players and umpires will be provided with bottled water.

7.4.3. Meals are provided for the Organiser's representatives, volunteers, umpires and VIP guests of the Tournament.

7.5. During the entire tournament period information desks for players (players' desk) will operate at the hotel for players and foreign umpires and at the tournament venues.

7.6. Medical services

7.6.1. During the entire tournament period the Chief Physician and the ambulance team are on duty. Emergency medical care is provided in accordance with Order No. 484n of the Ministry of Health of the Russian Federation dated June 19, 2026 "On Approval of the Procedure for Organising Medical care for Persons Engaged in Physical Education and Sports (including the period of the Preparation and Conduct of physical education and Sports events), including the procedure for medical examination of persons wishing to undergo sports training, engage in physical education and sports in organizations and (or) comply with the standards of tests (tests) The All-Russian Physical Culture and Sports Complex "Ready for Labor and Defense" (GTO) and the forms of

medical certificates on admission to participation in physical culture and sports events" and the tournament regulations.

7.6.2. Depending of the technical conditions at the venue the Organiser provides an additional service of sports massage in a designated area.

7.7. Security

7.7.1. The security of participants and spectators at the tournament is carried out in accordance with the requirements of the Rules for ensuring security during official sports competitions, approved by the Decree of the Government of the Russian Federation No. 353 dated April 18, 2014.

7.7.2. The security of participants and spectators at the tournament is carried out including by involving organisations authorized to provide the relevant services (private security guards, stewards, canine units, fire truck duty, and specialized equipment).

7.8. Additional services

7.8.1. The Tournament Organiser has the right to provide uniform items to client groups.

7.8.2. Optionally, the Tournament Organiser provides social events for client groups.

7.8.3. Optionally, the Organiser provides outdoor advertising in the city where the tournament is held, as well as promotion on social networks and the Internet to inform potential spectators and participants of the tournament.

7.8.4. The Tournament Organiser provides additional technical equipment and facilities at the tournament venues to ensure an appropriate level of service for spectators and participants.

7.8.5. The Tournament Organiser provides photo and video coverage of the tournament to promote the sport and provide an appropriate level of service for spectators and participants.

8. Branding

8.1. The venue of the tournament, the official hotel for main draw participants are branded in accordance with the developed branding concept.

8.2. If necessary, additional navigation elements are provided on the territory of the venue and along the routes of client groups.

9. Prizes

9.1. At the end of the final match the winners and runners-up of the tournament will be awarded commemorative prizes.

9.2. Based on their performance in the tournament players will receive prize money according to the table below.

Payments are made based on the athletes' positions in the results table.

Prize amounts are **before tax**. Foreign players bear full responsibility for paying taxes in accordance with the laws of their country of residence. The RPF performs the functions of a tax agent: it calculates and pays personal income tax from the accrued prize money in accordance with the laws of the Russian Federation.

Payment of prize money is made in accordance with the result sheet of the tournament within 30 days after the end of the tournament, provided that the requested personal data has been provided to the Organiser.

Participants of the tournament who are citizens of the Russian Federation will receive their prize money in rubles, and the currency conversion will be carried out based on the Central Bank exchange rate on the date of the end of the tournament, and in any event at a rate of no more than 100 rubles to the EUR.
